Item 1-Consideration of Regional Advisory Boards

The need for effective bottom-up communication has not been addressed historically. One idea to remedy this is to create "regional advisory boards," led (chaired) by the individual region's FPUSA Counselor(s), and made up of the region's club presidents and at-large representatives chosen by the Counselors and the Clubs.

Item 2-Consideration of the FPUSA Communications Strategy

Website, blog, social media, email, and potentially an annual publication are currently the key elements of the FPUSA communications strategy. The Communications Committee will present an outline plan, along with results from a brief survey relating to the annual publication.

Note: The "strategy" does not require Board approval. Expenditures required to execute on the strategy, if above the \$300 (traditional limit), will require Board consideration and approval.

Item 3-Consideration of 2019 Tournament Proposal

This proposal requires approval prior to the distribution to the clubs. In the past, the document was distributed as a "tournament bid request." This new format establishes certain criteria that clubs must meet in order to submit a request for tournaments. It also involves the Regional Counselors directly in the management of Regional tournaments.
